### 1) Publication of personal data

### 2) Making of Video Recordings

### 3) Correspondence by email

Sending emails via the internet carries a certain risk for data protection. ### 5) Passing on of contact data of legal guardians / of students to the elected parent representatives and parents of classes.

The purpose of collecting this data is to enable them to contact you, especially to transfer information and realize their tasks.

### 6) Cooperation päd-aktiv and school

### 8) Cooperation between school social work and school

In the context of collaboration it is necessary and important for the wellbeing of the child to exchange personally identifiable information between the school social worker and teachers of the primary schools of Heidelberg. All communications will of course adhere to strict confidentiality.

This consent may be withdrawn anytime for the future. Such withdrawal may refer also only to a part of the media or the type of data. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. In the case of printed material, consent shall not be withdrawable once the printing order has been made. In the event of withdrawal, the pertinent data will in future no longer be used for the purposes mentioned above and erased from the pertinent Internet offers without delay. If consent is not withdrawn, it shall be valid for the duration of school attendance with the data being erased upon the end of school attendance. Video recordings will be erased upon completion of the work assignment but no later than the end of the school year or the end of the course level or when the above purpose has been reached.

**Consent is given on a voluntary basis. No disadvantages shall accrue from refusal to giving your consent or withdrawing it.**

Vis-a-vis the school you have the right of access to your personal data; you moreover have the right to rectification, erasure or restriction, and the right to object to processing and a right to data portability. You moreover have the right to lodge a complaint with the data protection supervisory authority, the commissioner for data protection and freedom of information of the land of Baden-Württemberg.
